# **MANDATE**

The New Brunswick Arts Board is an arm's-length arts funding agency with a legislated mandate to:

Facilitate and promote the creation of art;

Facilitate the enjoyment, awareness and understanding of the arts;

Advise the government on arts policy;

Unify and speak for the arts community; and

Administer funding programs for professional artists.

The New Brunswick Arts Board was established in 1989 as part of the New Brunswick's government's fine arts policy: The New Brunswick Arts Board Act was assented to on November 9, 1990, and came into force on June 13, 1991. This act was amended in 1999 (An Act to Amend the New Brunswick Arts Board Act) in order to extend the autonomy and areas of responsibilities of the New Brunswick Arts Board.

The New Brunswick Arts Board is composed of twelve members, balancing gender, the five regions of the province, the various linguistic and First Nations communities, as well as the various artistic disciplines.

# MESSAGE FROM THE CHAIR

The basis of France Daigle's Pour sûr grew from an idea in Umberto Eco's The Open Work, which counsels the artist to "make large works...large...that open onto other things..."

Who could have predicted the unprecedented renewal this organization has undergone since our last Annual Report of September 2011. We are working collaboratively with a new government — a government that has not been silent on arts practice but which has chosen to take some bold measures, including the renewal of the Cultural Policy, which challenges the board as we try to offer our expertise on upcoming decisions. We now have a new Executive Director, Akou Connell, and we welcome her enthusiasm, her vision, her strong background in communications and her commitment to the arts. We have a full slate of new members on our board that are pan-provincial and interdisciplinary. They include Nathalie Cyr-Plourde in dance from Edmundston; Cynthia Sewell in First Nations arts from Papineau First Nation; Denis Lanteigne in visual arts from Caraquet; Pierre McGraw in classical music from Pokemouche; Deborah McCormack, an arts advocate from Saint John; Matthew Pearn in film and communications from Saint John; Monica Adair in architecture from Saint John, and returning board member Laura Ritchie, curator, Fredericton. Our staff, which consists of Vanessa Moeller, Deputy Director; Robert Bryar, Programs Officer; and Christine Murphy, Director of Administration, have kept this organization vibrant and transparent.

With renewal comes restructuring, and this has been enthusiastically undertaken by our executive comprised of Chet Wesley (Secretary-Treasurer), communications, Innovation NB, Fredericton; Nisk Imbeault (2nd Vice-Chair), gallery curator, Moncton; Gwyneth Wilbur (1st Vice-Chair), luthier, of St. Stephen; and myself on the recommendations of the Executive Director. In March 2012, we welcomed our new Marketing and Communications Specialist, Nathalie Rayne. With the proposition of online applications and a newly refurbished website, we will be capable of accepting a larger number of applications and a broader spectrum of programs. The I am art social media campaign was launched in April 2012 at the Frye Festival, and we hope it will help elevate the profile of our province's talented professional artists with the general public.

Recommendations from the Programs and Juries committee have recast some of the regulations concerning the Documentation program. Research has also been done on developing a data collection form to help us identify more readily who is successfully receiving our grants and where there are gaps, so we can ensure equity.

Our public profile is important to us. The most important initiative raising the public awareness of the arts is the annual Lieutenant-Governor's Awards for High Achievement in the Arts. New Brunswick is justly proud of this event, and by extension, also of the award recipients and their fine accomplishments. This past year's recipients: France Daigle in literary arts, Patrick Clark in theatre, and Yvon Gallant in visual arts, seemed deeply moved to be acknowledged at the gala. We are honored that the Lieutenant-Governor continues to host this annual event.

In an effort to reach regions of the province in which our programs are undersubscribed, we journeyed to Edmundston for our June meeting. Here the artists' reception was warm, and many of them appeared to be keenly interested in the work of artsnb. As board members, we came away feeling that expectations of us were high and that we were serving a very committed and competent clientele.

One of our overarching goals has been to involve the First Nations community more effectively. The Circle of Elders was reconvened to ensure First Nations participation at artsnb and the development of appropriate programs in the future.

The Youth Commission met for the first time last summer and worked hard, highlighting emerging NB artists as part of National Youth Arts Week. Their work is ongoing and continues to inform the Board.

The Education committee initiated a joint meeting with the Department of Culture, Tourism and Healthy Living and the Department of Education to share ideas on how we can work together on projects which engage professional artists in the formal education system. It was a beneficial first meeting and presented opportunities for further collaboration.

The regional project with the Town of Caraguet culminated this year, in accordance with the terms of our agreement. Tough decisions have had to be made regarding our budget, as funding from the province has remained static over the last nine years. Some of our programs have ended. This includes long term partnerships with Manitoba, and Quebec, which will end in the upcoming year, and also a pilot project with Maine. Other avenues for augmenting the amount of funds available are being explored, such as corporate sponsorship, stakeholder partnerships, and collaboration with Atlantic public arts funders.

artsnb's efforts to host tripartite meetings that combine all levels of government, and meetings with public and private funders to address gaps and duplication in public funding, position us as a cultural broker, particularly at a time when the Cultural Policy of the province is being revisited. In these meetings, it is staggering to see how many programs are available, the subscription of NB artists to them, the rates of success and failure in applications, and municipal efforts to engage the public in arts and culture. These sessions are invaluable in making connections which, over the long term, can only work in favour of the community we serve.

We continue to build closer ties with other arts organizations, including the New Brunswick Foundation for the Arts, ArtsLink, and AAAPNB. This included working with AAAPNB and ArtsLink to attend the announcement of the provincial budget and organizing a day to meet members of the legislative assembly, where the MLAs of both the Liberal and Conservative caucuses were witness to our unity of message and sense of purpose. Joint ventures, such as these, confirm to the government and the public that we are working together as a sector to better advance the role of culture and the professional artist in our society.

artsnb also works with several organizations to improve the impetus for Culture Days events that happen each September. The honorary chair of Culture Days this year, Freeman Patterson, spoke eloquently about how the arts contribute to the public's sense of well-being.

None of these changes have come easily. In my opinion, now that we have the personnel in place, it is time to renew our relationships with the artists in the province through active committee work in communications, programs and juries, and education. Our spirit of collegiality and our desire to improve the status of arts practice in New Brunswick can really make a difference.

As we move forward, it is an exciting time to be part of artsnb. Artistic practice continues to burgeon throughout the province; it is difficult to know all that is going on. Through all these initiatives, artsnb is resonating better with the community and arts practitioners across the province. There is, however, a lot of work left to do.

I am proud to be part of such a forward thinking and progressive organization, and I would like to applaud the energy and initiative shown by our staff over the last year, particularly our Executive Director, Akoulina Connell.

# MESSAGE FROM THE EXECUTIVE DIRECTOR

I've had one full cycle around the sun with artsnb and I have been getting to know my office team (Vanessa Moeller, Robert Bryar, Christine Murphy, and Nathalie Rayne are wonderful to work with) as well as the board. We have a strong executive in Tim Borlase (Chair), Gwyneth Wilbur (Vice-Chair), Nisk Imbeault (Second Vice-Chair), and Chet Wesley (Secretary-Treasurer). We've welcomed several new board members: Nathalie Cyr-Plourde, Deborah McCormack, Monica Adair, Denis Lanteigne, Pierre McGraw, Matthew Pearn, and Cynthia Sewell—and Laura Ritchie has valiantly continued her work on the board despite the effort she's putting into her Master's thesis. I've been travelling a lot, too, striving to get to every corner of the province to meet stakeholders. There is always more to explore, but so far I've been to Edmundston, Caraquet, Saint John, St. Andrews, Dieppe, Cambridge Narrows, Bouctouche, Moncton, and Bathurst. The reception has been warm everywhere I go—and the thrum of creative synergy is omnipresent. I feel a profound sense of optimism about our province's dynamic and amazingly diversified creative sector—it holds such great potential to shape the future of our province!

#### **Engage and Inspire**

It is of paramount importance to artsnb that we engage and develop deeper relationships with the artists we serve, the stakeholders with whom we collaborate, and the general public, whose quality of life is fundamentally impacted by the work of New Brunswick's artists. We held a Mojo Mixer in Saint John; established a social media presence and launched a social media public awareness campaign (9 video clips on 8 artistic disciplines have been developed and disseminated) on Facebook, Twitter, and YouTube; and updated our website and office space so that more emphasis is placed on showcasing the work of our clientele. In the coming year, we are working to ensure that online applications can be completed on our website (and supporting documentation/files can be uploaded directly), and that our database and reporting capabilities are updated so that artsnb is properly equipped with more robust tools to ensure that we are able to be more strategic in our approach to programming, and ultimately more accountable. We're exploring ways to reduce the environmental footprint of our paper-heavy jury process, as well.

Inspiration is a symbiotic process: it's easy to get excited about the amazing things our community is doing, and impossible to ignore. At artsnb, we want and need to find new, innovative ways to profile, celebrate, and raise public awareness of the excellent work produced by professional artists across New Brunswick.

#### **Equity and Innovation**

In Spring 2011, I was bundled off to my first Canadian Public Art Funders (CPAF) meeting—and the theme was equity. We discussed the importance of data collection, responsive programming, critical diversity, and systemic issues that

plague well-established funding models when it comes to responding to innovation, diversification, and changing demographics. Upon my return, artsnb staff reviewed our internal data and found that response and success rates for First Nations professional artists were far lower, on average, than the proportion of the population they represent (unlike Acadian representation in response and success rates, which is very much in line with demographic proportions in the province). The artsnb Circle of Elders (Shirley Bear, Imelda Perley, Gilbert Sewell, Mildred Milliers, and Carlos Gomez) was reconvened along with artsnb's First Nations Representative, Cynthia Sewell. We met to discuss the issue, identify challenges and opportunities, and work towards strategies to ensure that artsnb can move towards a culturally appropriate yet mandate-sympathetic solution.

The Circle of Elders indicated that something needed to be done to ensure that sustained resources are available to warrant that professional First Nations artists' work is being evaluated according to culturally relevant criteria by jurors who understand First Nations art, and that the work of First Nations artists be valorized within the province so that it becomes more visible. The Circle of Elders and artsnb then

embarked on a cross-jurisdictional review of provincial, territorial, and national funding programs for First Nations Art, with a view to identifying which elements of which programs were most needed in order to stimulate a renaissance in First Nations art in New Brunswick, develop capacity (without provincial grants for First Nations arts organizations/collectives/community groups, it is impossible for them to access Canada Council grants), encourage artistic mentorships to ensure that crucial transfer of knowledge from professionals to amateurs can transpire, and ensure that internships for arts administrators and budding curators are secured. Work continues on this front.

#### **Stakeholder Collaboration**

artsnb held two tripartite meetings to exchange ideas and updates on what's happening around the province, identify new opportunities, and discuss challenges (with federal, provincial, and municipal stakeholders); and two New Brunswick art funders meetings (with public and private stakeholders) to work towards identifying who is doing what, where the potential gaps in our ecosystem might be, and how we can work together more strategically to ensure that our arts ecosystem is properly nourished.

In conjunction with AAAPNB and ArtsLink, artsnb participated in the first ever Arts Day at the Legislature—an effort to raise awareness among the Conservative and Liberal caucuses on the important contributions of the arts and culture sector to quality of life, sense of collective identity, and the economy at large. At a juncture where the province is challenged to find solutions to a deepening fiscal crisis, the timing is key to ensure that the province understands the value proposition of working towards fostering a creative, expressive society that can innovate, think on its feet, and adjust to change.


The Atlantic Public Art Funders (which includes Executive Directors and Chairs from arts boards in Newfoundland, Nova Scotia, Prince Edward Island, and New Brunswick) met to reinitiate an effort to sign an MOU to work collaboratively on joint initiatives that will benefit the arts and culture sector of the Atlantic Region as a whole. Our goal is to sign the MOU in August, 2012, and work towards a first joint initiative with the support of the Canada Council: the development of opportunities for First Nations professional artists.

#### Arts and Culture: Shaping the Future

The more efficient, effective, responsive, and innovative we become as a funding organization, the better artsnb will be able to serve professional artists and the province at large. Public figures in our province speak often about the need to think outside the box...and yet few of them know how. Never before has the need for the active engagement of our province's creative resources been so urgent. We are at a crossroads, an intersection. The current financial crisis in our province is more than that: it is a unique opportunity to re-envision and re-imagine the shape of things to come.

As the Cultural Policy Renewal process unfolds in the coming months, it is my hope that the arts and culture sector will partner with other sectors in new, innovative ways. Who knows? We might emerge as a critical resource in honing our province's collective identity, education system, and health-care approach, not to mention fostering new directions for our economy that are more eco-friendly, nimble, and attractive to big thinkers who may want to make New Brunswick home. For artists, creativity and imagination are the daily grind. If we step up to the plate as a unit, we could have a big role to play.

# **ACTIVITIES OF** THE NEW BRUNSWICK ARTS BOARD 2011-2012

#### **NOMINATIONS**

During the year the composition of the New Brunswick Arts board (artsnb) changed. Pauline Banville-Pérusse, Greg Hemmings, Louise Blanchard, Kyle Cunjak, Benoît Duquay, Anne Simon-Crossman and David Umholtz all finished their mandates. We are sincerely grateful to them for the work accomplished during their respective mandates, and wish them great success in their new ventures. Joining the board were Cynthia Sewell, Denis Lanteigne, Matt Pearn, Monica Adair, Nathalie Cyr-Plourde, Deborah McCormack, and Pierre McGraw. With the changes, the current executive consists of Tim Borlase, Chair; Gwyneth Wilbur, 1st Vice-Chair; Nisk Imbeault, 2nd Vice-Chair; and Chet Wesley, Secretary-Treasurer.

#### **BOARD ACTIVITIES**

The Board held two business meetings and their Annual General Meeting (AGM) during the last fiscal year (FY). One business meeting (June 2011) was graciously hosted in Edmundston. The other business meeting (January 2012) and the AGM meeting (September 2012) were held in Fredericton.

#### **EXECUTIVE**

The Executive Committee met several times during the year. The Executive Director and the Chairperson participated in the national meeting of the Canadian Public Art Funders (CPAF) which was held in the Yukon in November. The Executive Director sat on the steering committee of CPAF and attended and organized several other meetings including two tripartite meetings (with federal, provincial, and municipal art funding stakeholders), and hosted a Mojo Mixer in Saint John.

The Chairperson and Executive Director participated, in conjunction with AAAPNB and ArtsLink, in the first ever Arts Day at the Legislature—an effort to raise awareness among the Conservative and Liberal caucuses on the important contributions of the arts and culture sector to the quality of life, sense of collective identity, and the economy at large.

#### **FINANCE**

The Board's fiscal year ended with a deficit of \$1,828. This deficit is due to a small administrative expense overrun.

Funds deferred from previous years allowed artsnb to continue running the Out of Province Residency programs with Quebec, Manitoba, and Maine in FY 2011-2012, but since no new funds have been secured for these programs, FY 2012-2013 will be the last year for these residency programs.

#### **PROGRAMS**

Funds for the New Brunswick Arts Board's (artsnb's) programs are awarded though juries of professional artists. During the past year, a total of 65 jurors from across the province took part in 15 juries at our board offices, across the province, and by teleconference. The creation program and the Lieutenant-Governor's Awards continue to be juried in a by-discipline peer review format, while the artsnb's other programs function with multidisciplinary juries. The board would like to thank all the jurors for their dedication to the peer review system.

FY 2011-2012 marked the final year of the Caraquet Regional Project as well as the end of the agreements for residency exchanges artsnb had with Le Conseil des arts et des lettres du Québec (CALQ), the Manitoba Arts Council (MAC) and the Maine Arts Commission. artsnb hopes to continue fostering exchanges with these provinces through the Career Development, Artist in Residence component as well as the Artist in Residence program.

The Programs and Juries committee has continued to work with the program officers to streamline the funding programs and to oversee the jury process. In the past year, the documentation program has been revamped to place the focus on fostering theoretical and critical discourse in the arts. The Programs and Juries Committee and New Brunswick Arts Board's Program Officers continue to work together to make our programs as accessible, functional, and relevant to our clients as possible.

#### CIRCLE OF ELDERS

FY 2010-2011 marked the end of the two-year pilot project to have two part-time First Nations officers from both communities promote the New Brunswick Arts Board in First Nations' communities throughout the province. In FY 2011-2012 the artsnb Circle of Elders (Shirley Bear, Imelda Perley, Gilbert Sewell, Mildred Milliers, and Carlos Gomez) was reconvened along with artsnb's First Nations Representative, Cynthia Sewell in order to discuss the issue of equity, identify challenges and opportunities, and work towards strategies to ensure that artsnb can move towards a culturally appropriate yet mandate-sympathetic solution to address the low response and success rates for First Nations professional artists to artsnb's programs.

Sustained resources, culturally relevant evaluation, and valorization of the work of First Nations artists were identified as areas of need. The Circle of Elders and artsnb then embarked on a cross-jurisdictional review of provincial, territorial, and national funding programs for First Nations Art, with a view to identifying which elements of which programs were most needed in order to stimulate a renaissance in First Nations art in New Brunswick, develop capacity, encourage artistic mentorships to ensure that crucial transfer of knowledge from professionals to amateurs can transpire, and ensure that internships for arts administrators and budding curators are secured. Work on these issues is ongoing and artsnb would like to thank the Circle of Elders for their continued dedication and hard work.

#### YOUTH COMMISSION

At the February 2009 board meeting, the New Brunswick Arts Board established a Youth Commission. The main mandate of this commission is to advise the board on the needs and preoccupations of the new professional artists as well as new trends in the arts. The first meeting of the commission took place in August 2011, in Dieppe. artsnb would like to thank Alicia Potter, Jared Betts, Amy Ash, Erica Sullivan, Raymond Sewell, Mélanie F. Léger, Joey Roy, Sébastien Belzile, Karine Gauvin, Jake Powning, Maryse Arseneault, Anika Lirette and Alison Gayton for their participation in the Youth Commission.

FY 2011-2012 also allowed artsnb to partner with the Arts Network for Children and Youth (ANCY) on the first ever National Youth Arts Week, an event to give young people ages 13 to 30 a chance to express and exchange their ideas, showcase their talents, get excited about art and creativity and celebrate their positive contributions to their communities and to Canada, building a network of young artists and leaders. Vanessa Moeller was the Community Coordinator for the province with members of the Youth Commission mobilizing youth in their communities and throughout the province. The first year was deemed a success throughout Canada and it is hoped that this event will continue on an annual basis.

#### LIEUTENANT-GOVERNOR'S AWARDS FOR HIGH ACHIEVEMENT IN THE ARTS


The third year of the Lieutenant-Governor's Awards for High Achievement in the Arts was a great success. Three \$20,000 prizes were awarded to France Daigle of Dieppe for French Language Literary Arts, Yvon Gallant of Moncton for Visual Arts, and Patrick Clark of Fredericton for Performing Arts. These awards honour professional artists who have achieved a high level of excellence in their professional artistic discipline in New Brunswick. The New Brunswick Arts Board would like to thank the Honorable Graydon Nicholas and his hard-working staff for helping make this a memorable event.

#### COMMUNICATIONS

This year artsnb added Nathalie Rayne to the staff as the Marketing and Communications Specialist. artsnb has been working hard to ensure that news of the New Brunswick Arts Board's program offerings, initiatives, partnerships, and awards reach the greatest possible number of New Brunswickers. Our goal is to do a lot with a little, raising the profile of our organization and the work we do for New Brunswick's professional artists and the province at large. We have initiated the "I am art" social media campaign, a series of short promotional film clips showcasing our artists and artistic disciplines. The clips will be released at various events throughout the province this fiscal year. We have also increased artsnb's visibility on Facebook, Twitter, and YouTube, and have overhauled our website to give it a fresh, cleaner interface.

#### **OPERATIONS**

The staff of artsnb performed wonderfully in FY 2011-2012. With considerable effort they produced the annual report, organized the Lieutenant-Governor's Awards for High Achievement in the Arts, and have been very active in their everyday activities, providing constant support to the Executive Director as well as to the Board. Their efforts and devotion are truly appreciated.

# STRATEGIC PLAN 2009-2012

#### **VISION**

The New Brunswick Arts Board envisions a culturally vibrant province whose respect for the arts and artists enriches the cultural diversity of its citizens. Through dynamic and responsible leadership, the NBAB strives to make artistic excellence, appreciation of the arts, and freedom of expression essential elements in the everyday lives of New Brunswickers.

#### **VALUES**

The New Brunswick Arts Board is committed to the following values:

#### Equity

Treating applicants from the various artistic disciplines in a consistent manner and according to standard criteria.

#### **Transparency**

Providing stakeholders with accurate and thorough information regarding the Board's funding programs and its operations.

#### **Diversity**

Valuing and respecting cultural differences and treating all groups in a culturallysensitive manner.

#### Leadership

Maintaining a visionary and action-oriented approach in partnership with various stakeholders, including the three levels of government and the arts community.

#### **Efficiency**

Providing programs and services of high quality and consistent standards.

#### **Democracy**

Ensuring that the decision-making processes of the Board are based on fair representation, consensus, and the principle of peer-review.

#### Innovation

Embracing new and path-breaking aesthetic approaches as well as stylistic, technical or conceptual advances within the established artistic disciplines.

#### **MISSION**

The New Brunswick Arts Board is an arm's length provincial crown agency with a mandate to facilitate and promote the creation of arts, to facilitate the enjoyment and understanding of the arts, to advise the government on arts policy, to unify and speak for the arts community, and to administer funding programs for professional artists.



#### STRATEGIC DIRECTIONS **AND PRIORITIES**

Through its policies and programs, the New Brunswick Arts Board strives to foster artistic excellence in New Brunswick. To this end, the Board must balance an increasing demand for funding and services against measured increases in its own funding. Based on the SWOT analysis and the vision statement, the board established the following priorities:


























#### **GRANTS BY DISCIPLINE** 2011-2012




ARTS SCHOLARSHIPS BY REGION 2011-2012




**CREATION AND DOCUMENTATION GRANTS BY REGION** 2011-2012

# FINANCIAL REPORT 2011-2012

#### INDEPENDENT AUDITOR'S REPORT

#### To the New Brunswick Arts Board:

I have audited the accompanying financial statements of New Brunswick Arts Board, which comprise the Statement of Financial Position as at March 31, 2012, and the Statement of Operations, Statement of Changes in Net Assets and Statement of Cash Flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

#### Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian Accounting Standards for Non-Profit Organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

#### Auditor's Responsibility

### NOTES TO THE FINANCIAL STATEMENTS

#### March 31, 2012

#### 1. Nature of Operations

The New Brunswick Arts Board was a branch of the New Brunswick government until January 2000. At this time, the Board became an arm's length agency. The purpose of the Board is to provide grants and scholarships to qualifying individuals and organizations to enable them to perform various art functions. It is exempt from corporate taxes under paragraph 149(1)(1) of the Income Tax Act.

#### 2. Summary of Significant Accounting Policies

#### Capital assets

Capital assets are recorded at cost less accumulated depreciation.

#### Revenue recognition and expenditures

The Board follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenditures are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Unrestricted investment income is recognized as revenue when earned.

Expenditures are recorded using the accrual basis of accounting.

#### Use of estimates

Under Canadian Generally Accepted Accounting Principles, management is required to make estimates and assumptions to prepare financial statements. These estimates are based on management's best knowledge of current events and actions that the Board may undertake in the future. These estimates and assumptions may affect the amount of assets and liabilities presented as at the reporting date and the reported amount of revenue and expenses during the fiscal period. Actual results may be different from the estimates and assumptions used.

#### Cash and temporary investments

Included in cash and temporary investments is cash on hand, balances with banks and short-term investments in cashable Canadian money market funds.

#### 10. Capital disclosure

The Board's objective when managing capital consisting of net assets is to safeguard its ability to continue as a going concern so that it can continue to provide benefits for artists.

The Board sets the amount of capital in proportion to risk. The Board manages its capital structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets. In order to maintain or adjust the capital structure, the Board may increase cash contributions by seeking additional sources of funding by undertaking other activities as deemed appropriate under specific circumstances.

The Board is not subject to externally imposed capital requirements and the Board's overall strategy with respect to capital risk management remains unchanged from the year ended March 31, 2011.

#### 11. Economic dependence

The Board derives a significant portion of its revenue under funding arrangements with the Province of New Brunswick.
